The Youth Worker will work within the guidelines, policies and mission of the agency and will be accountable to the Program Manager.

- support and/or co-facilitate child safety training program with volunteers, youth and parent/guardian
- plan, coordinate and facilitate small group activities (in person and online)
- support supervision of active caseload matches in accordance with National Standards
